Rider Code of Conduct

Drill Team Goal

To provide an opportunity for youth to develop drill team, leadership, and teamwork skills, and to represent and enhance the 4H Horse Project while creating a positive environment for the youth to develop mentoring skills.

Ground Rules

It is inevitable that conflicts or misunderstandings will arise. Initially, problems should try to be resolved at the personal level, as resolving conflicts is an important life skill. Leaders should be informed when a conflict arises but will only intervene as a last resort. Civil communication is key to resolving these conflicts.

Requirements to be a Drill Team Member

- Before participating with the team, 4HOnline enrollment must be complete, all youth must be a current "active" member of La Crosse County 4-H, and between grades 3 and 13 as of January 1st.
- Riders must be a 4H member in good standing and meet the 4H horse project requirements, including registering their drill team horse as an exhibited horse for the La Crosse County Fair.
- Riders must attend every Monday Night practice with a guardian unless previously excused by the coach (excused practices may include school functions, illness/death in family)

Participation

Success depends on 100% participation – sharing ideas, asking questions, and committing to practices and performances. Participation as a 4H member looks like:

- Remembering to be responsible and courteous
- Believing all ideas are valuable
- Sharing experiences
- Listening to understand
- Showing up and choosing to be present
- Honoring schedules and other's time

Ethics Statement

- I will be a responsible, accountable, and positive representative of the La Crosse County 4H Drill Team.
- I will respect all people, including myself.
- I will exhibit self-discipline.
- I will be fair and open.
- I will care about the members of the team.
- As a member of the Drill Team, I will not use alcohol or illegal substances.
- I will demonstrate good horsemanship and the responsible treatment of all animals.

I have read and agree to the La Crosse County 4H Drill Team rider code of conduct. If questions should arise I understand that I should contact the coach immediately.

La Crosse County 4H Drill Team Adult Sponsor Code of Conduct

My primary goal as a 4H adult is to help my child develop competency in their projects, confidence in themselves and others, connections to their community and sound character. As a 4H adult I will help my rider to participate to the best of their ability. I will promote teamwork and leadership while helping my rider(s) learn and have fun. The following are the expectations of all 4-H adult sponsors:

I realize as an adult sponsor of a 4H Drill Team rider, I will be a representative of La Crosse County 4H.

- I will model trustworthiness and honesty to all.
- I will treat all riders, coaches, adult sponsors, competing riders, judges, and others with respect, courtesy and consideration.
- I will not attack or harass anyone, (verbally or physically) with actions such as put-downs, insults, name-calling, yelling, or any other verbal or non-verbal conduct likely to offend, hurt or set a bad example.
- I will take responsibility for any interpersonal conflict that may arise with others, thereby demonstrating positive conflict resolution skills for youth members.
- I will keep myself informed and adhere to the La Crosse County 4H conduct policies and project guidelines.
- I will teach and model kindness and compassion for others. I recognize that all people have skills and talents which can be used to help others and improve the community. I will teach and foster teamwork and discourage selfishness.
- I will teach and model fair-mindedness by being open to ideas, suggestions and opinions of others. I will also treat everyone equally, regardless of race, creed, color, sex, national origin or disability. I will treat all 4-H members and their families with impartiality.
- I will demonstrate good horsemanship and the responsible treatment of all animals.
- I will not use illegal substances and will model responsible use of alcohol while adhering to state, county, and municipal laws and ordinances.
- I will provide a safe environment for all parties involved. I protect those involved from sexual harassment, physical force, verbal or mental abuse, neglect, or other harmful behaviors.

No policy can cover all possible situations. When policy is not specific on a point, adults are expected to conduct their activities in a socially acceptable manner.

If I do not adhere to the code of conduct, consequences may include:

- Explaining my actions to the La Crosse County 4H Extension office
- Dismissal from an event at my expense
- Further disciplinary action by the La Crosse County 4H extension staff, including:
 - Restriction from attending any further 4H Drill Team events or activities
 - My family, including my rider(s), being banned from participating in the La Crosse County 4-H Horse Project

I understand that my child may not participate in the La Crosse County 4H Drill Team without the signatures of each adult sponsor.
