- Membership Report
  - April 1st, 2025 was the deadline to sign up for the fair; 564 youth are currently enrolled, which is 22 more members than last year. 219 members are first generation members (meaning their parents were not involved in 4-H).
- Dairy Breakfast Update
  - The breakfast will be June 14th at the fairgrounds. Currently seeking 100 volunteers to help with the breakfast. Please ask around for people who are willing to help. Emily will place a call for volunteers into the Cloverline.
- Summer Camp Update
  - They will be capping the maximum number of participants this year at 100. If you are signed up, you must pay by June 1st to have a guaranteed spot.

# Agricultural Society Rep. Report:

Carolyn reported that there was a discussion that ear tags are on sale still for \$1 and sheep exhibitors do not need to buy tags ahead of time because they will be available at weigh in. The Pork Twilight meeting will be held on June 2nd. All pigs will need a rope test to participate this year in the pig project. For the fair, the dairy shed will be going forward as planned and construction will start May 1. There was discussion regarding extending the race track area, but no decisions have been made yet. The Ag Society board did not accept the ethics poster the Parents and Leaders Association Board discussed at the last meeting. A vote was taken by the Ag Society and the poster will only be allowed in the food stand. The board did not feel it was necessary to have the ethics poster in place. Next meeting will be May 7th, 2025.

# 4-H Ambassador Report:

4-H members can submit logo designs for new La Crosse County 4-H apparel. Ambassadors will vote for the top 3 designs, and then the top 3 designs will be put in the Cloverline for all 4-H participants to vote. The ambassadors will also sponsor a prize for this contest.
