**Extension Office update and report:**

- Foods Revue Report
  - 27 youth participated.
- Clothing Revue Report
  - 4 youth participated. This is a 50% increase from last year.
- Summer Camp Report
  - 29 people attended. 22 were youth, and 7 were chaperones and other adult volunteers. Camp went well!
- Achievement Ceremony Report
  - Everything went well.
- Goosechase Report
  - Many participants and people seemed to enjoy the experience
- AFR & Re-Enrollment deadline reminders
  - AFR's are due September 2nd. 4-H online is getting some updates, including updates to trainings. Background checks will be done every 2 years. Reenrollment will open September 5th. Leaders need to start the reenrollment process by November 1st.
- Goals for 2025-2026 Leaders Board
  - Brainstorming of what potential goals could be moving forward. Emily asked that folks think of ideas and bring them to the next meeting.
  - Annual Leader Meeting

  - Sue was able to pay all outstanding bills. Tentative earnings are approximately \$22,900. There is about 300 pounds of meat leftover, which will be used for Oktoberfest and Sue will reach out to community partners to see if anyone is interested in purchasing it.
  - Positive feedback of the interior layout of the foodstand.
  - Discussion of the benches and seating near the food stand. Carolyn will bring up removal of the benches to the Ag society.
  - Continued difficulties with finding something for the Cloverbuds to do. This could include a buddy system or having them stock items.
  - Discussion of buying more tongs, changing the nacho trays and cheese curds, and providing better written instructions for certain stations.
